## ***VISITING PROFESSOR CALL FOR APPLICATIONS - Ukraine Emergency***

### **Introduction**

The University of Modena and Reggio Emilia promotes support measures for Ukrainian teachers and researchers to carry out teaching and research activities at the departments of the University as Visiting Professors.

### **Preliminary information**

Pursuant to Article 23, paragraph 3 of Law 240/2010, the call for applications provides for the allocation of a funding to Ukrainian Teachers and Researchers from Ukrainian Universities and Research Centres and called to collaborate with the Departments of the University for a period of **4 months** on site for carrying out mainly teaching activities.

### **Budget**

The Budget allocated by the University to cover the remuneration of Visiting Professors amounts to € 60,000 for the activation of 5 Visiting Professor positions, who will be paid a € 12,000 amount (gross of the costs that shall be borne by the University) for a duration of 4 months.

The Visiting Professor will receive the following remuneration, indicatively:

Gross monthly remuneration: € 9,000 approx.

### **Eligibility**

The call is open to Ukrainian teachers and researchers who enjoy the temporary protection regime as established by the Implementing Decision of the European Council of 4 March 2022 (EU 2022/382)

Applications shall be submitted in PDF format and sent via email through the departments to the address [relint@unimore.it](mailto:relint@unimore.it) by **May 6<sup>th</sup>, 2022**, by filling out the attached form (Ann.1), which is an integral part of the call for applications. The application shall include the following:

- curriculum vitae of the applicant, with a list of his/her 5 most relevant publications/monographies of the last 5 years
- Department decision confirming the approval of the application submission (mentioned decision can be temporarily replaced by a letter of the Director of the Department to be later ratified by the Department's bodies)
- plan of the teaching/research activities that will be carried out during his/her stay;

The activities that will be carried out in the departments shall be agreed with the reference professors of the University.

### **Economic terms and conditions**

Remuneration shall be intended inclusive of any cost to be borne by the Administration and the receiver, as well as of the following expenses: travel, visa and residence permit, accommodation and board, health insurance, and the premium for the compulsory extension of the "Third party and employer's civil liability" insurance coverage.

The foreign recipient will decide whether s/he should request the application of the international agreements against double taxation (Tax Treaty) where applicable, and submit the certification issued by the relevant Authority of his/her own country.

### **Selection procedure**

The applications submitted by the Departments will be assessed by a Board appointed by the Rector, based on the following criteria:

- curriculum vitae of the applicant;
- time schedule of the activities planned during the stay.

Applications relating to those who have already held the role of Visiting Professor at the University will also be evaluated.

### **Activities**

At the end of the period of stay at the University, the Visiting Professor shall draw up a comprehensive report on the activity carried out, which the hosting structure will send to the International Relations Office. Should the host be unable to carry out part of the activity for which he/she was called, the remuneration will be reduced accordingly.

### **Contract**

The selected Visiting Professor shall sign a self-employment contract with University of Modena and Reggio Emilia.

Any other activity related to the task assigned shall be authorised by the hosting structure with no additional charges borne by the University. The hosting structure shall ensure the internal logistics and space accessibility to the Visiting Professor for the entire stay.

The remuneration will be paid on a monthly basis.

Any contract signed for teaching activities under this article shall not give rise to rights of access to university roles.

For anything not expressly provided for in this notice, please refer to the general principles found in our legal system as applicable.
