Dear Colleagues,  
Dear Students,

I would like to inform you of what was decided yesterday by the Academic Senate on how to carry out the teaching activities of the coming months.

### **Teaching activities of the second semester of a.y. 2021/2022:**

In the light of the current epidemiological situation, the Senate has established that in the second half of the year the same decisions taken for the first are maintained, namely:

- the commitment of the University to promote and carry out activities in face-to-face mode as a matter of priority;
- the obligation for professors to provide adequate teaching material electronically for all students, in the manner decided by each department, in order to fully guarantee the right to study;
- compliance with the individual and collective prevention measures indicated by the regulatory actions and the provisions of the University;
- the use of classrooms and laboratories at 100% of their capacity, subject to various regulatory provisions and different indications of the University Board that will meet soon. It is understood that, where it is feasible in terms of number of students and availability of spaces, the distance of one meter between each other is recommended as a measure in addition to the use of the mask and the possession of the green pass.

Finally, I would like to remind you that lectures will not resume before 28 February 2022.

### **Examinations and final degree exam:**

The same arrangements are also maintained for examinations and final degree exams scheduled until the end of the special session.

Therefore, exams are held in face-to-face mode, with the opportunity to be held remotely for:

- people who have tested positive for SARS-Cov-2 virus, even with nasal rapid swab for domestic use;
- quarantined people;
- people with weaknesses relating to COVID-19;
- people cohabiting with persons with COVID-19 fragility;
- people who are in areas from which, in relation to any restrictions due to classification in an area of high epidemiological risk, movements are not authorised;
- people who, based on the area of origin, need long-distance means of transport, with the consequent risk of exposure to contagion;
- people who are unable to be present on the day of the examination for reasons related to the administration of the vaccine scheduled for the day of the appeal, the day immediately preceding or the day immediately following the examination;
- Italian citizens or foreign people residing abroad;
- people cohabiting with SARS-Cov-2 positive subjects or waiting for the swab results;
- people who, not on their own responsibility, have not obtained the necessary certification in good time.

The request must be communicated directly to the teacher in charge of the exam, at least 24 hours in advance of the start time of the exam round, by filling in a special self-declaration available at the link <https://www.unimore.it/covid19/ModuloRichiestaEsameaDistanza.docx> as well as in ESSE3 when registering for the exam.

### **Teaching activities of the first semester of a.y. 2022/2023:**

With regard to the teaching activities of the next academic year, which will begin in September, the Academic Senate has decided on the following guidelines:

- the commitment of the University to promote and carry out activities in face-to-face mode as a matter of priority, of course without prejudice to any regulatory provisions involving different assessments;
- at the same time, the commitment of the University to provide the recording of lectures or equivalent digital teaching material. I would like to point out that Unimore is committed to the above regardless of the state of

emergency pandemic.
